Severe Test for Automobiles.

 ment from Chicago to-night. They will
 patrol the entire course during both races.

Cobe Cup Race Saturday.

On Saturday will be run the Cobe cup
 race, in which twelve cars will compete
 for the trophy put up by Ira Cobe, presi-
 dent of the Chicago Automobile Club. Be-
 ginning at 8 a. m., the cars will get away
 a minute apart and drive around the
 course seventeen times. The experts say
 it will be finished by 3 o'clock in the aft-
 ernoon.

hicle and afoot. All the railroads reaching Chicago will run hourly trains, the first of which will start at 1 a. m.

Then, too, from all points of the compass road vehicles will be pouring into the vicinity of the course during the night and early morning. Hundreds of automobile parties will be forming in Chicago at dawn and striking southward for the shrine, where for two days the auto fans will worship the speed god.

Until 7 a. m. vehicles will be permitted to travel to the grandstand and the neighboring parking spaces on the east leg of the course. After that hour the only approach will be by way of Main street, in Crown Point. Vehicles and pedestrians will cross the course on temporary viaducts into an eighty-acre field within the course.

It is a mile and a half from Crown Point to the main grandstand, and hundreds of buses and other vehicles will be on hand to transport spectators from the trains to the course. Once within the course access to the grandstand will be gained by foot bridges at the starting point.

More than 200,000 persons are expected to witness the race tomorrow, and even more than that number on Saturday. The grandstand that has been erected by the Chicago Automobile Club will hold 15,000 spectators, while more than fifty smaller stands at various points along the course will hold a total of 10,000 more.

Thousands more will view the races from the porches of city houses and farm dwellings and along the high wire fences that protect the roads. In addition automobile parties who wish to remain in their cars will see the race from more than fifty parking spaces established in the wayside fields and meadows and flanking the grand stand and official headquarters at the starting and finishing points.

The seats in the main grand stands and in many of the smaller stands are on sale at \$5 each, this entitling the purchaser to privileges for the two days. Some of the private stand owners are selling seats at \$5 each a day, lodging and breakfast included.
