HARDEST RUN OF TRIP TO DATE
SET FOR TODAY.

FEW CARS DRAW PENALTIES

CHICAGO, July 14.—With the novelty of the first days of the Glidden tour almost worn away, participants in the sixth annual reliability run of the American Automobile Association left Chicago for Madison, Wis., today many of them facing a new proposition, that of an endurance contest.

The run to Madison is the most strenuous yet to be made, 175.2 miles. Water breakers will be encountered on the way for the first time and, while the roads are in good condition, the motorists anticipated the day's run with little enthusiasm. From Chicago to Milwaukee the road is largely of macadam, gravel and sand, while sand and clay is encountered between Milwaukee and Madison.

Run from Kalamazoo Strenuous.

Chairman Hower and Charles J. Glidden, in the official Premier car No. 99, led the long caravan of automobiles into Chicago yesterday afternoon, after a strenuous day's run from Kalamazoo, Mich. The smooth highways of northern Indiana proved a pleasant relief after the heavy sand found on the roads of Michigan. The fastest time was made between South Bend and Chicago, where smooth stretches of macadam road afforded the first opportunity for speeding.

The first of the contestants to check in officially was H. G. Smith, Premier car No. 99. William Bolger, driving Chalmers-Detroit car No. 3, was second. The other contestants finished in the following order: Cars No. 100, 108, 8, 9, 106, 111, 10, 30, 101, 107, 75, 97, 1, 2, 4, 112, 7, 14, 110, 105, 11, 104, 2, 11, 5, 4, 102, 104 and 118. Brush car No. 103, F. A. Trenkle, driver, was penalized 1/4 of a point for tightening a cone on an axle, and Chalmers-Detroit car No. 3, William Bolger, driver, was given a similar penalty for wiring a fender. Brush car No. 104 and McIntyre No. 110 were late in arriving, and the penalties will not be announced until the meeting of the contest board tonight. The cars were parked in Grant street, opposite the Annex hotel.

The motorists were entertained last night at a luncheon given by the Chicago Motor Club. Moving pictures of the Crown Point-Lewis races were a feature.
